Induction Training	8.2	<ul style="list-style-type: none"> <li>• All staff will confirm that they have completed Induction Training and reviewed the training materials provided by the Department of Education</li> </ul>
Return To Work Form (RTWF)	8.1	<ul style="list-style-type: none"> <li>• All staff and Students on School Placement have been provided with access to the Return to Work (RTW) form;</li> <li>• All staff and Students on School Placement (verbally or in writing) will be requested to confirm that the details in the pre- return-to-work form remain unchanged.</li> </ul>

Access to School	4.7	Access to the school building will be in line with agreed school procedures. i.e. by appointment only and with Contact Tracing Log in place.
Infection Prevention Control Measures - To prevent Introduction and Spread of COVID19 in Schools	5	<ul style="list-style-type: none"> <li>• Staff and pupils advised to self-isolate or restrict their movements at home if they display any signs or symptoms of COVID-19 and to contact their family doctor to arrange a test.</li> <li>• Staff and pupils advised not to return to or attend school in the event of the following: if they are identified by the HSE as a close contact of a confirmed case of COVID-19 -if they live with someone who has symptoms of the virus -If they have travelled outside of Ireland; in such instances staff are advised to consult and follow latest Government advice in relation to foreign travel.</li> <li>• Staff and pupils advised to cooperate with any public health officials and the school for contact tracing purposes and follow any public health advice in the event of a case or outbreak in the school.</li> </ul>

Know the Symptoms of COVID-19	5.1	High temperature, Cough, Shortness of breath or breathing difficulties, Loss of smell, of taste or distortion of taste.
Respiratory Hygiene	5.2	This means covering your mouth and nose with a tissue or your bent elbow when you cough or sneeze. Then dispose of the used tissue immediately and safely into a nearby bin.
Hand Hygiene	5.3	<ul style="list-style-type: none"> <li>• Hand hygiene can be achieved by hand washing or use of a hand sanitiser (when hands look clean).</li> <li>• Use of hand hygiene facilities including wash hand basins will be managed so as to avoid congregation of people waiting to use wash hand basins and hand sanitisers.</li> <li>• There is a requirement for access to handwashing facilities after activities that are likely to soil hands, for example playing outside or certain sporting activities as hand sanitiser does not work on dirty hands</li> <li>• Alcohol-based sanitiser will not be stored or used near heat or naked flame</li> </ul>
Frequency of Hand Hygiene	5.3	<ul style="list-style-type: none"> <li>• Pupils and staff should perform hand hygiene: On arrival at school; Before eating or drinking; After using the toilet; After playing outdoors; When their hands are physically dirty; When they cough or sneeze.</li> </ul>
Sharing of Items	5.4	<ul style="list-style-type: none"> <li>• Staff will bring their own utensils (cup, cutlery, plate/bowl etc.) and use antibacterial wipes to clean common touch points e.g. microwave handle, burco handle, table and chair frame after use.</li> </ul>
Physical Distancing – In School	5.4	<p>Increasing separation</p> <ol style="list-style-type: none"> <li>1. Reconfigure class spaces to maximize physical distancing</li> </ol>

		<p>2. Utilise and reconfigure all available space in the school in order to maximize physical distancing</p> <p><u>Decreasing interaction</u></p> <p>Bubbles &amp; Pods At least 1m distance between pupils</p>
Physical Distancing: School Drop Off/Collection	5.4	<ul style="list-style-type: none"> <li>• Walking/cycling to school will be encouraged as much as possible.</li> <li>• Signage to be displayed encouraging distance of 2m between Parents and guardians and between parents and guardians and school staff.</li> <li>• Pupils will head straight to their designated area in the playground or on wet days to their classroom.</li> <li>• Plan in place to ensure staggered exit from school at end of day.</li> <li>• Parents requested to wear face masks on school grounds</li> <li>• Parents asked not to congregate.</li> </ul>
Physical Distancing: Staff	5.4	<ul style="list-style-type: none"> <li>• A distance of 2m is recommended for physical distancing by staff</li> <li>• If 2m cannot be maintained in staff groups, as much as distance as is possible and guidance on face covering should be observed.</li> <li>• Physical distancing should be observed between staff members within the staff room through the use of staggered breaks, break out points etc. To avoid congregation of staff waiting to use the kitchen, the kitchen area will not be in use until it is safe to do so.</li> <li>• Staff meetings should be held remotely or in small groups or in large spaces to facilitate physical distancing.</li> </ul>

Physical Distancing: Yard Supervision	5.4	<ul style="list-style-type: none"> <li>• Play time/outdoor activities adjusted to minimise crowding at the entrance and exits.</li> <li>• Yard divided out to facilitate different classroom/bubbles.</li> </ul>
Ventilation School will fully comply with Department guidance on the practical steps for good ventilation in accordance with public health advice 'Practical Steps for the Deployment of Good Ventilation Practices in Schools'. (Nov 2020)	5.4	<ul style="list-style-type: none"> <li>• Windows will be open as fully as possible when classrooms are not in use (e.g., during break-times or lunch-times (assuming not in use) and also at the end of each school day)</li> <li>• Windows will be partially open when classrooms are in use.</li> </ul>
Masks	5.5	<ul style="list-style-type: none"> <li>• Cloth Masks are not recommended for children and for Staff, masks/visors are not required if physical distancing is possible</li> <li>• Medical grade masks in the EN14683 category will be provided to all teachers in special classes and those staff by necessity that need to be in close and continued proximity with pupils with intimate care needs including School Bus Escorts. Our school is providing these masks to all staff</li> <li>• A supply of FFP2 surgical masks will be provided to SNAs and staff involved in close, intimate personal care and aerosol generating activities.</li> </ul>
Gloves	5.5	Generally, not appropriate
Choir/Music	6	Well ventilated room and distancing or Outdoors
School Activities	6	Refer to HPSC guidelines
